The paper prepares students for relatedjobs in the financial sector, and assist them in taking informed important personal financial decisions such as taking out a mortgage, purchasing insurance, or saving for a pension
ECNHDSE602	Environmental Economics	Course objective: This course aims to focus on economic causes of environmental problems; in particular, how economic principles are applied to environmental questions and their management through various economic institutions, economic incentives and other instruments and policies. It also aims to address

		Economic implications of environmental policy as well as valuation of environmental quality, quantification of environmental damages, tools for evaluation of environmental projects such as cost-benefit analysis and environmental impact assessments.  Course outcome: This course focuses on economic causes of environmental problems. In particular, economic principles are applied to environmental questions and their management. ECNGDSE3	Environmental Economics	Course objective: This course introduces students to concepts, methods and policy options in managing the environment using tools of economic analysis. This course should be accessible to anyone with an analytical mind and familiarity with basic concepts of economics. # Paper III: History of the English Language, Critical Terms, and Classical Mythology

The students will also be able to understand common critical terms and concepts in order to hone their critical skill and sensibility. #### Paper XI: Criticism II

After completing this course, the learners shall be able to acquaint themselves with major critical texts from the Romantic period to the twentieth century and contextualize critical terms and frames of reference that would be useful for the understanding and analysis of literary texts. Moreover, the course will help them to understand the various trajectories of growth of literary criticism.

#### Paper XII: Literature of the USA

After completing this course, the learners shall be able to acquaint themselves with seminal American texts in order to help them understand the complexities of American culture as well as the relevance of the American ideals to the Indian situation.

#### Paper XIII: Literature in the Postcolonial World

After completing this course, the learners shall be able to acquaint themselves with seminal postcolonial novels in order to help them understand the complex negotiations between the colonizer and the colonized and the transformations in societies and cultures in India and African regions.

#### Paper XIV: Introduction to Linguistics and Phonetics

After completing this course, the learners shall be able to acquaint themselves with some basic concepts associated with language. Moreover, the students will also be familiar with the sound system of English and English syntax to stimulate effective communication in English.

#### **General English**

# Paper I

After completing this course, the learners shall be equipped some of the basic skills in written communication. Apart from learning the use of language, the student would learn the different modes of writing and comprehension which shall include analysis and interpretation. The students would be familiarized with guidelines for writing of reports, notes and memos.

# Paper II

Students shall also be able to fairly gather, understand, evaluate and synthesize information from a variety of written and electronic means. Students shall be able to understand the process of communicating and interpreting human experiences through literary representation using historical contexts. Students shall be able to use English effectively in formal and informal situations. Students shall be able to attempt creative writings. Students shall be able to develop verbal and non-verbal skills of communication. Students shall be able to make a career in allied sectors.

**Course Outcomes** 

**BA English (Core)** 

#### Semester I

#### **COURSE 1: INDIAN CLASSICAL LITERATURE**

Objective: The objective of this course is to acquaint the students with the rich cultural heritage of ancient Indian literature, especially Sanskrit Literature.

Outcome: After completing this course, the learners shall be able to appreciate the creative excellence and artistic/aesthetic sensibility of immortal plays written in Sanskrit like Kalidasa's Abhignana Shakuntala, the epics The Mahabharata and Sudraka's Mricchakatika and the classical sensibility of immortal classics like Srimanta Sankardeva's Parijata Harana.

#### **COURSE 2: EUROPEAN CLASSICAL LITERATURE**

Objective: The objective of this course is to acquaint the students with the great heritage of European classical literature.

Outcome: After completing this course, the learners shall be acquainted with immortal classics like *The Iliad* and *Metamorphosis*, they will learn about the difference between the Greek classics and the Latin classics, the different genres dabbled in by the classical writers, such as, tragedy, comedy, epic, satire, criticism and so forth.

#### Semester II

#### **COURSE 3: INDIAN WRITING IN ENGLISH**

Objective: The objective of this course is to introduce the learners to Indian Writing in English from the colonial to the postcolonial period. Issues such as identity politics, gendered differences, home, dislocation and language are underscored with the intention to understand the diversity of Indian culture and tradition across spatiality.

Outcome: After completing this course, the learners shall be acquainted with the Indian Writers - poets, novelists, essayists, and dramatists who have been making momentous and considerable contributions to world literature since pre - Independence era. The students will be familiarized with wide ranges of themes like Indian culture, tradition, social values and even Indian history

through the depiction of life in India and Indians living elsewhere and also the Indian experience of the modern predicaments.

COURSE 4: BRITISH POETRY AND DRAMA: 14<sup>TH</sup> TO 17<sup>TH</sup> CENTURIES

Objective: The objective of this course is to acquaint the learners with British poetry and drama

from Chaucer to Shakespeare.

Outcome: After completing this course, the learners would be familiarized with the Age of

Chaucer, Pre-Elizabethan and Elizabethan periods.

Semester III

**COURSE 5: AMERICAN LITERATURE** 

Objective: The objective of this course is to introduce the learners to American literature,

highlighting issues like the reality or illusion of the Great American Dream, the

Transcendentalist Movement, the history of slavery in the South, the great economic depression

etc. in the context of American history and literature.

Outcome: After completion of this course the learners would get a feel of American literature

and they will be able to understand the poetics and politics of a literature characterized both by

liberal and reactionary ideals.

**COURSE 6: POPULAR LITERATURE** 

Objective: The objective of this course is to acquaint the learners with popular literature, such as

children's literature, crime thriller, LGBT fiction, graphic fiction, and so forth, generally

regarded by purists to be 'low-brow' and meant for easy mass consumption.

Outcome: After the completion of this course, the learners would be able to appreciate the

presence of a creative space and process that has the potential to affect readers to a degree that

high-brow literature cannot achieve due to its propensity to target only a niche audience.

COURSE 7: BRITISH POETRY AND DRAMA: 17th AND 18th CENTURIES

Objective: The objective of this course is to acquaint the learners with the experience of a whole

gamut of feelings that define a period and contradistinguishing it from the romantic excesses of

the Elizabethan literature to a literature marked by restraint and order.

Outcome: After the completion of this course, learners will be in a position to understand the

ways in which English drama and poetry began to emphasize on the importance of adhering to

classical norms and forms.

Semester IV

**COURSE 8: BRITISH LITERATURE: 18TH CENTURY** 

Objective: The objective of this course is to acquaint the learners with the fundamental

philosophical shift that ushered in, in the wake of the culture of positivism that set in during this

period.

Outcome: After the completion of this course, learners will be able to understand the spirit of the

age, as well as the literature embodying this spirit.

**COURSE 9: BRITISH ROMANTIC LITERATURE** 

Objective: The objective of this course is to acquaint the learners with the spirit of the age. The

students will be familiarized with the highly imaginative, rhetorical, emotive, visionary,

metaphysical, epical, sensuous aspects of the works of this age, especially poetry, which gave

tremendous heft to this literature celebrating Nature in all its beauty, majesty and terror. The

students will also be familiarized with Gothic Novel which attempted to debunk the structure of

rationality by emphasizing on the reality of the supernatural.

Outcome: After completion of this course the learners would be able to know and appreciate the

values of a literature characterized by emotion, passion, love towards nature, exerting of

imagination and so forth in order to create a thing of beauty, which would be a joy forever.

**COURSE 10: BRITISH LITERATURE: 19TH CENTURY** 

Objective: The objective of this course is to provide the learners a fascinating opportunity to immerse into the fraught historical context determined by contradictory, oppositional drives and processes.

Outcome: After completion of this course the learners will be able to understand the philosophical shift that came about due to the crises of faith pertaining to the culture of positivism that manifested its full presence during the Victorian period. It is also hoped that they would be able to understand concepts like utilitarianism, surplus value, Victorian prudishness, survival of the fittest etc., and will be able to analyze it along these lines.

#### Semester V

#### **COURSE 11: WOMEN'S WRITING**

Objective: The objective of this course is to introduce learners to women's writing, and in doing so attempting to underline the manner in which power operates to silence women from articulating their views. Apart from that, the course would also try to situate women's writing in a space that transcends or upends the male writing tradition through various subversive ways.

Outcome: After completion of this course the learners will be sensitized to gender- related issues, and would be able to see things from the perspective of the Other.

#### COURSE 12: BRITISH LITERATURE: THE EARLY 20TH CENTURY

Objective: The objective of this course is to chart the philosophical trajectories like symbolism, existentialism, cubism, Dadaism, expressionism, nihilism etc. through early twentieth- century texts, particularly novels and poetry.

Outcome: After completion of this course the learners will be acquainted with concepts like stream-of-consciousness, Oedipus complex, avant garde, gyre, interior monologue, among many others.

#### Semester VI

#### **COURSE 13: MODERN EUROPEAN DRAMA**

Objective: The objective of this course is to read some of the select modern plays of Europe by placing the epochal events of the period as the backdrop.

Outcome: After completion of this course the learners will be in a comfortable space to know Modern drama with its entire attendant problematic.

#### **COURSE 14: POSTCOLONIAL LITERATURES**

Objective: The objective of this course is to introduce postcolonial literature to the learners focusing mainly on such issues as language, identity, point of view, displacement, physical and mental colonization, Decolonization, nationalism, fundamentalism, globalization and Diaspora, colonial legacy, gender and sexuality, regionalism, ethnicity, genocide, race, and so forth, and how such issues are expressed in the literary texts prescribed in the syllabus.

Outcome: The learners on culmination of the course are expected to be acquainted with both the texts and the contexts of the given period.

#### **BA English (Generic Elective)**

Semester I

#### **COURSE 1: ACADEMIC WRITING AND COMPOSITION**

Objective: To prepare students for work in high level English courses in which research writing is a requirement. It introduces basic research writing skills including: conducting research, note taking, paraphrase, summary, direct quotation, positioning, and MLA or APA style citation.

Outcome: By the end of the course, students will be able to demonstrate and apply knowledge of basic essay structure, including introduction, body and conclusion; employ the various stages of the writing process, including pre-writing, writing and re-writing; employ descriptive, narrative and expository modes; demonstrate ability to write for an academic audience; write concise sentences, etc.

#### Semester II

#### **COURSE 2: MEDIA AND COMMUNICATION SKILLS**

Objective: To introduce learners to media and communication skills. In this digital-visual landscape, it is necessary to be equipped with knowledge and technical expertise of new media. This course will enable learners with skills pertaining to mass communication in all its manifestations.

Outcome: It is expected that this course will act as a beginner's guide to media communication. It will enable them to opt for a career in journalism, television or digital media by continuing their study in this field in more rigorous terms in their Postgraduate level.

#### Semester III

#### **COURSE 3: LANGUAGE AND LINGUISTICS**

Objective: To familiarize students with the structure, morphology, phonology, syntax, semantics of a particular linguistic system, which is English. The learners will get to know about the deep structure of the system and study it in a synchronic mode.

Outcome: The learners will get familiarized with the science of the study of the English language. This will enable them to unravel the morphology, phonological dynamics of the language, thereby making them motivated in researching on a scientific study of language.

#### Semester IV

#### COURSE 4: CONTEMPORARY INDIA: WOMEN AND EMPOWERMENT

Objective: This course will familiarize learners with gender issues related to its construction legislation, resistance and marginalization in the pan-Indian context. The objective of this course is to sensitize learners to the multiple forms of subjugation that patriarch subjects women. It will also attempt to suggest strategies to resist or subvert such strategic silencing by means of an

alternative discourse –feminism –a means to empower what Simone de Beauvoir ironically

termed as the "second sex".

Outcome: The learners will get acquainted with gender issues, including the politics of how it is

constructed, reinforced and sustained. They will get apprised of women's resistance against

patriarchy through women's movements, and well as understand the silence of twice

marginalized sections, like Dalit women and tribal groups.

**BA English (Discipline Specific Elective)** 

Semester V

**COURSE1: MODERN INDIAN WRITING IN ENGLISH TRANSLATION** 

Objective: This course aims to acquaint learners with the works of Indian writers working on

regional literature from the north to the south, from the west to the east.

Outcome: After completing this course, it is expected that learners will be in a position to

appreciate the literature of India as it exists in various regional languages. They would be able to

understand the political, social and economic factors affecting people across regions and

cultures.

**COURSE 2: LITERATURE OF THE INDIAN DIASPORA** 

Objective: To introduce the learners to literature of the Indian Diaspora keeping in view the

issues that haunt the writers who have settled abroad, despite being Indians in terms of roots and

emotional make-up.

Outcome: After completing this course, it is expected that learners will be in a position to

understand the complexity of living as hyphenated identities in a space which is different from

that of "home". They will be in a better position to understand the postcolonial condition of

identities caught between the quest for a better life abroad and the acknowledgement of the

futility surrounding such a rootless mobility.

**COURSE 3: LITERARY CRITICISM** 

Objective: To present an overview of major trends in literary criticism from the Romantic period

to the present and to introduce to the recent trends in criticism, particularly feminist criticism.

Outcome: It is hoped that the learners will be in a position to understand the texts in terms of the

contexts, which could be purely aesthetic, historical, textual or political. They will be able to

read texts by adopting the ideologies of the different reading processes.

**COURSE 4: WORLD LITERATURES** 

Objective: To enable the learners to know about the form and content of texts those are part of

different spatiality.

Outcome: By the end of the course, the student will be able to identify and analyze a variety of

major works of world literature; compare and contrast writing styles and generic forms from

different periods and cultures; identify major themes of representative poetic and fictional works,

and trace the influence of one literature upon another.

Semester VI

**COURSE 5: LITERARY THEORY** 

Objective: To acquaint learners with four relevant discourses or theories. These are Marxism,

Feminism, Poststructuralism, and Postcolonial Studies.

Outcome: By the end of this course, the learners shall be in a position to know some of the

significant texts of discourses revolving around class, gender, power, language, race, identity and

so forth. They will be able to relate their reading of literature through such theories, which would

in turn facilitate their interpretive strategies.

**COURSE 6: LITERATURE AND CINEMA** 

Objective: This course investigates relationships between two media, film and literature, studying works linked across the two media by genre, topic, and style. It aims to sharpen appreciation of major works of cinema and of literary narrative.

Outcome: The learners are expected to understand the elements involved in adapting texts to film. They will demonstrate analytical skills in visual literacy and reading filmic texts. Students will demonstrate a familiarity with ways of discussing and evaluating films as reflections of cultures and source texts.

#### **COURSE 7: PARTITION LITERATURE**

Objective: The objective of this course is to read literature that captures the sense of the twentieth-century subcontinent's history when Partition was perhaps the most horrific event of the times. There will also be film screenings since cinema also helps capture both the horror and the repercussions of these events.

Outcome: After the culmination of this course, the learners will be in a position to comprehend the magnitude of the tragedy of partition and realize how the trauma associated with it impinges on the victim's daily lives and activities even in the present. The historical fact transmuted by imagination tends to prove the validity of literature in representing the truth of the human condition.

#### **COURSE 8: TRAVEL WRITING**

Objective: To read travellers' accounts of places from the past to the present encompassing writings of eminent travel writers from the medieval period to the present. The course will attempt to underscore the problematic associated with the genre, such as, the claims to authenticity of the narrativised events, the role of imagination, the ethnocentric gaze, the element of wonder, and so forth.

Outcome: The learners would be in a position to understand the cultural dynamics of narratives written by travellers. They will be able to appreciate the difference in representation from the category of gender, religion and race. They will realize that travel narratives are always already ideological in import, and hence they can only be regarded as representations, rather than truth.

#### **BA English (Ability Enhancement Compulsory Course)**

Semester I

#### **COURSE 1: ENGLISH COMMUNICATION**

Objective: To introduce students to the theory, fundamentals and tools of communication and to develop in them vital communication skills which are integral to personal, social and professional interactions.

Outcome: It is hoped that after studying this course, students will find a difference in their personal and professional interactions.

#### **COURSE 2: ALTERNATIVE ENGLISH**

Objective: To introduce students to select literary works of different genres and to enhance their skill of the English language.

Outcome: It is hoped that after studying this course, students will be able to develop a taste for English literature.

#### **BA English (Skill Enhancement Course)**

Semester III

#### **COURSE 1: ENGLISH LANGUAGE TEACHING (ELT)**

Objective: To acquaint the learners with the methodologies of teaching English in classroom situation and to acquaint them with the tools and strategies of ELT.

Outcome: The learners will be in a position to acquire skills pertaining to teaching English.

**COURSE 2: SOFT SKILLS** 

Objective: This course provides the soft skills required mainly for professional achievements,

and in the process, many of the personal requirements of an individual can be compiled with.

Outcome: it is expected that after completion of this course the learners will acquire soft skills

such as communication skills, work ethic, positive attitude, emotional intelligence and other

personal attributes crucial for success in business or career.

Semester IV

**COURSE 3: CREATIVE WRITING** 

Objective: To acquaint the learners with the craft and technicalities of creative writing.

Outcome: It is hoped that this course would be beneficial for the learners to develop their skills

in creative writing.

**COURSE 4: BUSINESS COMMUNICATION** 

Objective: To give students a comprehensive view of communication, its scope and importance

in business, and the role of communication in establishing a favourable outside the firm

environment, as well as an effective internal communications program.

Outcome: Students will learn how to enhance their business communication with technically

based media. This course will make them conversant with the basic forms, formats and

techniques of business writing so that they will be thoroughly prepared to take part in real-world

business fields. This course will also give them the latest research information on language in

general and the writing process specifically so that they will become a highly confident and

skilled writer. This course will provide discussion of all relevant communicational theories so

that they can apply this knowledge to a myriad of different communicational tasks and genres.

# **Objective of the Course**

# **BA** (Major) History

**Course Objective and Outcome** 

#### SEMESTER I

#### Course 1

## **Title of the Paper: INTRODUCTION TO HISTORY AND ITS SOURCES**

**Objective:** The objective of the course is to introduce to the students to the basics of the discipline of History and acquaint them to understanding of its sources in their varied forms, contents, uses and analysis.

**Outcome:** It is the most important study that gives knowledge to the students about the basics of History writing. This paper gives knowledge to the students about the sources of History of the three period of Indian History i.e. Ancient, Medieval and Modern History and also about the History of Assam.

#### **SEMESTER II**

#### **Course II**

#### Title of the Paper: EARLY AND MEDIEVAL ASSAM UPTO 1826

**Objective:** The objective of the paper is to give a critical outline of the political Theory of Assam from the earliest time to its occupation by the East India Company in the 1<sup>st</sup> quarter of 19<sup>th</sup> century. It aims at acquainting the student with major and significant stages of development in the course of History of the state of Assam since early time.

**Outcome:** By studying this course the students will be benefitted with the knowledge of the Kingdoms that existed in the land from earliest time like Varmanas, Palas, Salastambhas, Ahoms, Chutias, Bhuyans Kacharies, Koches and their political and cultural condition during the period.

#### **SEMESTER III**

## **Course III**

#### Title of the Paper: HISTORY OF ASSAM: 18826-1947

**Objective:** The course aims at introducing the students to understanding the focus and aspects of changes and developments in the socio-political and economic life of Assam during the colonial period.

**Outcome:** With this paper the students will come to know about the political condition of Assam during British period and their annexations, administration followed by the uprisings and the movements against the British rule.

#### **Course IV**

# **Title of the Paper: SOCIAL AND ECONOMIC HISTORY OF ASSAM**

**Objective:** The objective of the course is to acquaint the students with tha socio-economic history of ancient, medieval and colonial Assam. The development of caste system, religious beliefs, agriculture and land system, the social organization, trade and commerce, various agricultural regulation, plantation economy, development of modern industries, transport system, education, the emergence of middle class, development of literature and press and growth of public association will be analyzed.

**Outcome:** Besides political History, this paper gives knowledge about the socio-economic and religious condition of History of Ancient, Medieval and Colonial Assam.

#### **SEMESTER IV**

#### Course V

## Title of the Paper: HISTORY OF INDIA (FROM THE EARLIEST TIME TO 1200 AD)

**Objective:** This paper intends to acquaint the students with the emergence of state system in north India, the development of imperial state structure, the state formation in the Deccan and in South India in the early period. The paper will apprise the students with the changes and transformation in polity, economy and society in the early period and the cultural interaction of early India with Southern Asian countries.

**Outcome:** This paper helps students by giving knowledge about political condition of India from the period of Indus valley Civilization followed by the Janapadas, Mauryas, Guptas, Pallavas, Chalukyas Cholas etc.

#### **Course VI**

#### Title of the Paper: HISTORY OF INDIA (From 1200-1750 A.D.)

**Objective:** The objective of the paper to acquaint the pupils with political development in India between 1200-1750. It requires the pupils to understand the states in Medieval Times, Administrative apparatus and society, economy and culture of India in Pre-Modern period.

**Outcome:** The outcome of the paper is that it gives knowledge about the political and administrative condition of Delhi Sultanate and Mughal period along with the rise of Maratha under Shivaji. The pupils also come to know about the religious condition of the period.

#### SEMESTER V

#### **Course VII**

#### **Course VII**

**Objective:** The objective of this paper is to acquaint the undergraduate students about the major trends and developments that took place in Europe which ushered in Modern Age.

**Outcome:** This paper will help the students to acquire knowledge of transition from feudalism to capitalism, the voyages to the new world, the Renaissance. It also helps to gain knowledge about reformation movement in Europe and also rise of absolutism and enlightened despotism and also about Napoleon.

#### **Course IX**

# Title of the paper: HISTORY OF EUROPE (1815-1945)

**Objective:** The objective of this paper is to acquaint the students with the major political developments in Europe from 1815 to 1945. This course aims to bring to the students an understanding of the courses of transition of the continent from nation states to the major colonial powers.

**Outcome:** This paper helps student to acquaint knowledge about the condition of Europe prior to World war I including the Congress of Vienna, Unification of Italy and Germany, Eastern Question, Role of Russia. It also give knowledge about 1<sup>st</sup> World war and Italy under Mussolini and Germany under Hitlar.

#### Course X

# <u>Title of Paper: TOURISM IN NORTH-EAST INDIA: HISTORICAL DIMENSION</u>

<u>Objective</u>: This paper intends to give the students an idea about Tourism in North East India with special reference to the historical monuments and places of North eastern region of the country as heritage site of the nation. It aims to acquaint them with the growing vocation of Tourism as an Industry and the applicability of Historical knowledge for its growth.

**Outcome:** This gives the knowledge of Tourism and its definition and also focuses on the Historical remains and culture of various places of Assam that attracts the tourists. This also make student aware of places of wildlife of tourist interest

#### Course XI

# Title of the paper: HISTORY OF ECOLOGY AND ENVIRONMENT IN INDIA

#### **Course XIII**

#### **SEMESTER I**

Course I

Title of Paper: HISTORY OF ASSAM: 1228-1826

**Objective:** The objective of this paper is to give a general outline of the History of Assam from the 13<sup>th</sup> century to the occupation of Assam by the English east India Company in the first quarter of the 19<sup>th</sup> century. It aims to acquaint the students with the major stages of developments in the political, , social and cultural history of the state during the medieval time.

**Objectives:**This course is divided into five units. The Course helps the student familiarize with the basic normative concepts of political theory. Each concept is related to a crucial political issue that requires analysis with the aid of our conceptual understanding. This exercise is designed to encourage critical and reflective analysis and interpretation of social practices through the relevant conceptual toolkit. Further this course introduces the students to the important debates in the subject. These debates prompt us to consider that there is no settled way of understanding concepts and that in the light of new insights and challenges, besides newer ways of perceiving and interpreting the world around us, we inaugurate new modes of political debates

**Outcomes**: After the completion of the course students will be in a position to understand the basic normative concepts of political theory. The course will acquaint the students with the key concepts of political theory like Freedom, Equality, Justice and rights. The course will also encourage the students to gather vast knowledge of the important debates of political theory.

Paper: 2.2

Paper Code: C-2

Title of the Paper: Political Process in India

**Objective**: Actual politics in India diverges quite significantly from constitutional legal rules. An understanding of the political process thus calls for a different mode of analysis - that offered by political sociology. This course maps the working of 'modern' institutions, premised on the existence of an individuated society, in a context marked by communitarian solidarities, and their mutual transformation thereby. It also familiarizes students with the working of the Indian state, paying attention to the contradictory dynamics of modern state power.

**Outcome**: The course will guide the students to acquire knowledge on actual politics in India that diverges quite significantly from constitutional legal rules. The course will acquaint the students with Political Parties and Party System, Elections and Political Behaviour, Regional Aspirations, Religion Caste and Politics and the changing nature of Indian state. The course shall also help the students in various competitive examinations.

#### Semester III

Paper: 3.1

Paper Code: C-5

#### Title of the Paper: Introduction to Comparative Government and Politics

**Objective:** This is a foundational course in comparative politics. The purpose is to familiarize students with the basic concepts and approaches to the study of comparative politics. More specifically the course will focus on examining politics in a historical framework while engaging with various themes of comparative analysis in developed and developing countries.

**Outcome:** After the completion of the course the students will be in a position to understand the basic concepts and approaches of Comparative Politics. It will enable the students to gain knowledge on various themes of comparative analysis like historical context of modern government, themes for comparative analysis in developed and developing countries.

Paper: 3.2

Paper Code: C-6

#### Title of the Paper: Perspectives on Public Administration

**Objective**: The course provides an introduction to the discipline of public administration. This paper encompasses public administration in its historical context with an emphasis on the various classical and contemporary administrative theories. The course also explores some of the recent trends, including feminism and ecological conservation and how the call for greater democratization is restructuring public administration. The course will also attempt to provide the students a comprehensive understanding on contemporary administrative developments.

**Outcome:** After completion of the course the students will be in a position to understand the various classical and contemporary administrative theories like Scientific Management Theory, Human Relations Theory, Rational Decision making theory, Ecological Approach, innovation and entrepreneurship etc. The course will also help the students to cultivate knowledge on Public Policy Peoples` Participation, New Public Management. It shall help the students to gain knowledge on the recent trends like feminist and ecological perspective of public administration. The course will help the students to sit for competitive examinations.

Paper: 3.3

Paper Code: C-7

#### Title of the Paper: Perspectives on International Relations and World History

**Objective:** This paper seeks to equip students with the basic intellectual tools for understanding International Relations. It introduces students to some of the most important

theoretical approaches for studying international relations. The course begins by historically contextualizing the evolution of the international state system before discussing the agency structure problem through the levels-of-analysis approach. After having set the parameters of the debate, students are introduced to different theories in International Relations. It provides a fairly comprehensive overview of the major political developments and events starting from the twentieth century. Students are expected to learn about the key milestones in world history and equip them with the tools to understand and analyse the same from different perspectives. A key objective of the course is to make students aware of the implicit Euro -centrism of International Relations by highlighting certain specific perspectives from the Global South.

**Outcome:** The course will help the students to acquire knowledge on the basic concepts and theories or worldview of International Relations like Realism, Liberalism. It will provide knowledge on Critical perspectives of International Relations like Marxist Approach, Feminist Approach, Euro-Centricism and Perspectives from the Global south. The course gives insight to World War I and World War II, Fascism, Nazism, Cold War. It will also help the students to acquire specific knowledge on Global South. After the completion of the course, the students shall be in a position to analyse the political developments and events in the twentieth century.

Semester IV

Paper: 4.1

Paper Code: C-8

Title of the Paper: Political Processes and Institutions in Comparative Perspective

**Objective:** In this course students will be trained in the application of comparative methods to the study of politics. The course is comparative in both what we study and how we study. In the process the course aims to introduce undergraduate students to some of the range of issues, literature, and methods that cover comparative political studies.

**Outcome:** After the completion of the paper the students will be in a position to understand the comparative methods to the study of politics. The course will help the students to acquaint with the approaches to studying comparative politics, Electoral and Party System, Nation-State, Democatisation, federalism etc.

Paper: 4.2

Paper Code- C-9

Title of the Paper: Public Policy and Administration in India

**Objective**: The paper seeks to provide an introduction to the interface between public policy and administration in India. The essence of public policy lies in its effectiveness in translating the governing philosophy into programs and policies and making it a part of the community living. It deals with issues of decentralization, financial management, citizens and administration and social welfare from a non-western perspective.

#### Outcome:

After completion of the course, the students will be able to understand the interface between public policy and administration in India. The course will acquaint the students with Public Policy processes in India, Decentralization, Local Self Government in both rural and urban areas, Budget cycle in India. The course will also give insight to citizen and administration interface like Public Service delivery, Redressal of Public Grievances (RTI, Lokpal, Citizen Charter and E-governance) in India. The course will also help the students in various competitive examinations.

Paper: 4.3

Paper Code: C-10

**Title of the Paper: Global Politics** 

#### Course objective:

This course introduces students to the key debates on the meaning and nature of globalization by addressing its political, economic, social, cultural and technological dimensions. In keeping with the most important debates within the globalization discourse, it imparts an understanding of the working of the world economy, its anchors and resistances offered by global social movements while analyzing the changing nature of relationship between the state and trans-national actors and networks. The course also offers insights into key contemporary global issues such as the proliferation of nuclear weapons, ecological issues, international terrorism, and human security before concluding with a debate on the phenomenon of global governance.

**Outcome**: The course shall help the students to understand the basic concept of Globalisation with its political, social, cultural and technological dimensions. After completion of the course, students shall gain knowledge on contemporary global issues like proliferation of nuclear weapons, ecological issues, international terrorism, human security etc.

#### Semester V

Paper: 5.1

Paper Code: C-11

#### Title of the Paper: Classical Political Philosophy

**Objective:** This course goes back to Greek antiquity and familiarizes students with the manner in which the political questions were first posed. Machiavelli comes as an interlude inaugurating modern politics followed by Hobbes and Locke. This is a basic foundation course for students.

**Outcome**: The course shall help the students acquiring knowledge on ancient Greek Tradition. After completion of the course, students shall be in a position to understand the contribution of Plato, Aristotle, Machiavelli, Hobbes and Locke.

Paper: 5.2

Paper Code: C-12

#### Title of the Paper: Indian Political Thought-I

**Objective:** This course introduces the specific elements of Indian Political Thought spanning over two millennia. The basic focus of study is on individual thinkers whose ideas are however framed by specific themes. The course as a whole is meant to provide a sense of the broad streams of Indian thought while encouraging a specific knowledge of individual thinkers and texts. Selected extracts from some original texts are also given to discuss in class. The list of additional readings is meant for teachers as well as the more interested students.

**Outcome**: After completion of the course the students shall acquire knowledge on Indian political thinkers. The course shall help the students to understand the Traditions of Pre-Colonial Indian Political Thought. The course shall provide knowledge Ved Vyasa, Manu, Kautilya, AbulFazal, Kabir etc.

#### Paper: DSE-1A

#### Title of the Paper: Contemporary Politics in Assam

**Objectives:** The primary aim of this paper is acquaint with the students with the politics of contemporary Assam and its neighbouring states. Moreover, being located in the Northeast region it is invariably the concern of the students to have proper understanding of the region.

**Outcome**: The course shall help the students to understand the contemporary politics of Assam. After completion of the course the students shall be in a position to understand the inter-state relationship between Assam and other neighbouring states of North- East India.

#### Paper:DSE-1B

#### **Title of the Paper: Dilemmas in Politics**

**Objective:** This course is designed to explore, analyse and evaluate some of the central issues, values and debates in the contemporary world that has a bearing on normative political inquiry. The eight issues selected as dilemmas, though not exhaustive, are some of the salient ones discussed across societies.

**Outcome**: After completion of the course the students will be in a position to analyse the moral economy of violence, politics of Exclusion etc. and feminism and the politics of interpretation as well.

#### Paper: DSE-2A

#### **Title of the Paper: Human Rights in Comparative Politics**

**Objective:** This course attempts to build an understanding of human rights among students through a study of specific issues in a comparative perspective. It is important for students to see how debates on human rights have taken distinct forms historically and in the contemporary world. The course seeks to anchor all issues in the Indian context, and pulls out another country to form a broader comparative frame. Students will be expected to use a range of resources, including films, biographies, and official documents to study each

theme. Thematic discussion of sub-topics in the second and third sections should include state response to issues and structural violence questions.

**Outcome:** After completion of the course the students will be in a position to understand Human Rights in a comparative perspective especially how debates on human rights have taken distinct forms historically and in the contemporary world. The course will also help the students to acquire knowledge on Institutional Arrangements that work for the expansion of Human Rights throughout the globe.

Paper: DSE-2B

#### Title of the Paper: Development Process and Social Movements in Contemporary India

Course objective: Under the influence of globalization, development processes in India have undergone transformation to produce spaces of advantage and disadvantage and new geographies of power. The high social reproduction costs and dispossession of vulnerable social groups involved in such a development strategy condition new theatres of contestation and struggles. A variety of protest movements emerged to interrogate and challenge this development paradigm that evidently also weakens the democratic space so very vital to the formulation of critical consensus. This course proposes to introduce students to the conditions, contexts and forms of political contestation over development paradigms and their bearing on the retrieval of democratic voice of citizens.

**Outcome**: The course will provide knowledge on how under the influence of Globalisation the development process got transformed. After completion of the course the learners will be able to analyse various protest movements that emerged to interrogate the development paradigm in India.

Semester VI

Paper: 6.1

Paper Code: C-13

#### Title of the Paper:Modern Political Philosophy

**Objective:** Philosophy and politics are closely intertwined. We explore this convergence by identifying five main tendencies here. Students will be exposed to the manner in which the questions of politics have been posed in terms that have implications for larger questions of thought and existence.

**Outcome**: The course will help the students acquire knowledge on Modernity, Renaissance, Enlightenment, Gandhi's Critique to modern civilisation, postmodernism etc. The course will also provide knowledge on J.J.Rousseau, J.S.Mill, karl Marx's philosophy. After completion of the course the learners will be able to analyse

Paper: 6.2 Paper Code: C-14

Title of the Paper: Indian Political Thought-II

**Objective:** Based on the study of individual thinkers, the course introduces a wide span of thinkers and themes that defines the modernity of Indian political thought. The objective is to study general themes that have been produced by thinkers from varied social and

temporal contexts. Selected extracts from original texts are also given to discuss in the class. The list of additional readings is meant for teachers as well as the more interested students.

**Outcome**: After the completion of the course the students will be in a position to understand general themes that have been produced by Indian political thinkers from varied social and temporal context. The course will provide knowledge on Reformist Political Thinkers, Nationalist Political Thinkers and will give insight to the Cultural Nationalism in India.

# Paper: DSE 3A

#### Title of the Paper: Public Policy in India

**Objective:** This course provides a theoretical and practical understanding of the concepts and methods that can be employed in the analysis of public policy. It uses the methods of political economy to understand policy as well as understand politics as it is shaped by economic changes. The course will be useful for students who seek an integrative link to their understanding of political science, economic theory and the practical world of development and social change.

**Outcome**: The course will help the students to understand the theoretical and practical understanding of public policy. After the completion of the course the students will be able to understand politics as it is shaped by economic changes. The course will also help the students to analyse how interest groups and social movements play active role in Public Policy Making. The course will provide insight to the Policy and Decision-Making process in India. The course will also introduce the students with the Ideological standpoint of making of Public Policy in India specially Nehruvian Version, Economic Liberalisation and Inclusive development.

#### Paper: DSE 3B

#### **Title of the Paper: Understanding Global Politics**

**Course Objectives:** This course aims to provide students a basic yet interesting and insightful way of knowing and thinking about the world around them. It is centred around three sets of basic questions starting with what makes the world what it is by instructing students how they can conceptualize the world and their place within it. The second module focuses on the basic fault lines that drives the world apart and the last one is designed to help students explore how and why they need to think about the 'world' as a whole from alternate vantage points.

**Outcome:** After the completion of the course the students will be able to have an interesting and insightful way of thinking about the contemporary world. The course will help the students to analyse what makes the world what it is. Providing knowledge on the global economy the course will help the students to know about the transnational economic actors that tend to control the world. The course will also help the students to known what drives the world apart. Global inequalities, violence like conflict, war and global terrorism have driven the world apart. Simultaneously Global Environmental Crisis has been one of the prominent issues that needs

#### Paper: DSE 4A

#### Title of the Paper: India's Foreign Policy in a Globalizing World

**Objective:** This course's objective is to teach students the domestic sources and the structural constraints on the genesis, evolution and practice of India's foreign policy. The endeavour is to highlight integral linkages between the 'domestic' and the 'international' aspects of India's foreign policy by stressing on the shifts in its domestic identity and the

corresponding changes at the international level. Students will be instructed on India's shifting identity as a postcolonial state to the contemporary dynamics of India attempting to carve its identity as an 'aspiring power'. India's evolving relations with the superpowers during the Cold War and after, bargaining strategy and positioning in international climate change negotiations, international economic governance, international terrorism and the United Nations facilitate an understanding of the changing positions and development of India's role as a global player since independence.

**Outcome**: The course will help the students to understand the basic concepts of India's foreign policy. After completion of the course the students will be in a position to understand India's Relations with the U.S.A and U.S.S.R, India's engagements with China as well. The course, further introduces the students with India's role in South Asia. The learners, after completing the course will be able to learn India's negotiating style and strategies in terms of Nuclear proliferation, Climate Change, Foreign Economic Policy etc.

# Paper: DSE 4B Title of the Paper: Understanding South Asia

**Objective**: The course introduces the historical legacies and geopolitics of South Asia as a region. It imparts an understanding of political regime types as well as the socioeconomic issues of the region in a comparative framework. The course also apprises students of the common challenges and the strategies deployed to deal with them by countries in South Asia.

**Outcome:**After completion of the course the students will be able to understand South Asia as a region specially Historical and Colonial Legacies of the region and Geopolitics of South Asia. The course will give insight to the Politics and Governance of the region. Further, the course will also help the students to know about the socio-economic issues of the region specially movements and conflicts over language, religion, ethnicity etc. After completing the course the students will be able to analyse the Regional issue and challenges in the region such as dispute over international borders, dispute over internationally shared rivers and distribution of water resource.

# **B.A.** (CBCS) SOCIOLOGY (Honors)

Sociology is the study of human society; the way people live and interact in the world. It takes a scientific approach to the study of society, social structures, and practices. As a result since its very inception the discipline has played a central role in the intellectual growth of social sciences across the globe. Faculties and the departments teaching behavioral and social sciences in universities all over the world. A bachelor program in sociology is divided into courses under three major heads – fundamental and core areas, technical skill enhancement and elective subjects.

The fundamental course focus on the foundational & core areas within the discipline – the major theoretical and methodological trends, the major areas in which sociological research has occurred in global & Indian sociological traditions, & the contemporary trends in the discipline.

Elective courses are the choice-based course where students may opt for courses that are particular to their interest from a wide area of available option such as Industrial sociology, sociology of media, sociology of law, clinical sociology and others. The course will help the students to understand the society and individual. The course introduces several papers such as political sociology, sociology of religion, sociology of gender, economic sociology, social stratification, sociological thinkers, research methods etc. The course will also help the students to understand and analyze the inter-relationship between social institution and its effects on society through comprehensive teaching.

# **Critical thinking**

The course C.B.C.S, B.A. (Honors) in sociology is of higher education which emphasizes in developing critical thinking among the learners. Critical sociological thinking refers to the ability to logically and reasonably evaluate an

argument or problem while maintaining an awareness of and sensitivity to social forces and context. Critical thinking is that it is open to possibilities, seeks out information, and is willing to trust logic and empirical data to take us in the right direction. This thinking purposeful, deliberate, and self-regulatory, and arrives at judgments based on well-defined criteria and evidences. The course provides some papers that are framed in such a way that students will be able to analyze the sociological phenomena, and its different execution. After completion of the course, the student will be in a position to analyze the social realities with a critical view.

Modern society provide people to make their life more fruitful with new achievements and position in society by the opportunity of mobility.

# Core Course 11 Title of the paper-Sociological Thinkers – I

### **Objective:**

This course introduces the students to the classics in the making of the discipline of sociology through selected thinkers. The pioneer of sociology August Comte, Karl Marx, Max Weber, Emile Durkheim's great work and contribution to this field makes the subject more effective.

### **Outcomes:**

Students will learn the theories related with sociology by which they will able to achieve knowledge on the subject. This paper helps the students to have an orientation to classical theories in the making of the discipline of sociology.

# Core Course 12 Title of the paper-Sociological Research Methods – I

# **Objectives:**

This course is a general introduction to the methodologies of sociological research methods. It will provide the students with some elementary knowledge of the complexities and philosophical underpinning of research.

### **Outcomes:**

Research methodology is transformative and central to an enhanced postgraduate research experience. Research methods courses offer students the opportunity to learn the various aspects of the research process, framing useful research questions, research design, data collection, analysis, writing and presentation. # Core Course 13 Title of the paper-Sociological Thinkers – II

# Core Course 14 Title of the paper-Sociological Research Methods – II

This is an introductory course on how research is actually done with emphasis on formulating research design, methods of data collection, and data analysis. It will provide the students with some elementary knowledge on how to conduct both, qualitative and quantitative research.

This course will let students form more knowledge on how a sociological research is one, the various data collection methods, data analysis and research design. All of this will let students master the research area and become sociological thinkers and researchers.

### **Discipline Specific Elective 03**

### **Environmental Sociology**

### **Objective:**

This course is designed to introduce students to the core debates of environmental sociology, different approaches within the sub-discipline and how these approaches may be used to understand environmental issues and movements in India.

### **Outcome:**

This course will let students learn and understand all the aspects of environmental sociology and its various sub-disciplines. It will provide the students with clearer picture of India's environmental condition and issues.

# Discipline Specific Elective 04 Sociology of Work

### Objective:

# Generic Elective 01 Title of the paper- Indian Society: Images and Realities

This course seeks to provide an interdisciplinary introduction to Indian society. It will help students for sociological understanding of the Indian Civilization, Colony, Nation and Society. Different Indian institution like caste, religion, ethnicity, family and gender political economy are the prime concepts have to understand.

### **Outcomes:**

This course will help students formulate more thoughts and understand the Indian society. It will also provide an understanding of the Indian civilization, its colony as well as the whole nation.
